2016 FOOD BOOTH RULES AND REGULATIONS

1. Food booths will be outdoors.
2. No primary food items will be duplicated! HOWEVER, we will not monitor secondary food items.
3. Food vendors WILL BE ALLOWED to sell ***non-alcoholic DRINKS*** of their choice. If you plan to sell drinks, please indicate what you will be serving on your entry form.
4. All food must be prepared in an approved, state-inspected facility and must be served according to state regulations.
5. No entry forms will be accepted without the exact measurement of your trailer as ready for display.
6. A Vehicle access permit will be mailed with confirmation letter. Each entry is allowed one (1) vehicle access permit. **The permit allows you into the food area for unloading, and then your vehicles must be removed to vendor parking until you load after the completion of the show.**
7. No four wheelers, golf carts, bicycles, motorized scooters, mules, etc. will be allowed. No exceptions, regardless of circumstance.
8. Food booths will be set up Friday, September 2nd, from 8:00 a.m. to 11:00 a.m. & be ready to sell food items at noon Friday to 4:00 PM Saturday.
9. You will have **ASSIGNED** booth spaces. These spaces will be marked on the ground according to the dimensions that you have indicated on your entry form. YOU WILL NOT BE ALLOWED TO PICK YOUR OWN SPACE ON-SITE.
10. You are responsible for having and displaying a valid sales tax number, for collecting and submitting sales tax to the State of Texas Comptroller. The Brady/McCulloch County Chamber of Commerce is NOT responsible for collecting or submitting your sales tax.
11. You are responsible for the cleanliness of your area. Any space left in disarray or with loose trash or garbage will disqualify you from future participation.
12. No firearms will be allowed in Richards Park. Violators will be asked to leave the area and will not be allowed to participate.
13. Gambling will not be permitted in Richards Park. Violators will be asked to leave the area and will not be allowed to participate.
14. The Arts & Crafts Executive Committee shall be the final authority on interpretation of the rules, regulations, and selection of vendors.
15. The Brady/McCulloch County Chamber of Commerce shall not be responsible for any accidents, lost, stolen or damaged property or hurt feelings.
16. The sale of any item(s) that may prove harmful is strictly PROHIBITED.
17. NO REFUNDS ----- RAIN OR SHINE -----No exceptions, regardless of circumstance.
